Guidelines for Online Marketing



DOMAIN
NAMES

Do not use Dosti Realty Ltd. or project names in domain names.

Example

- ✗ [www.dostiprojectname.](http://www.dostiprojectname.com)



QR CODE

All communications should include a valid QR code related to the project.



APPROVAL

All digital communications must be approved by the Dosti Realty Ltd. brand team.



INCOMING
CALLS

Representatives must state that they are an Authorized Sales Partner of Dosti Realty Ltd.



PRE-LAUNCH
PROJECTS

Any information about upcoming or unlaunched projects is not to be circulated to customers or marketed unless authorised by Dosti Realty Ltd in writing. Incase you have already published such information remove the communication immediately.



BUSINESS/
GOOGLE
LISTING

Do not create a Dosti Realty Ltd. business listing or Google listing.

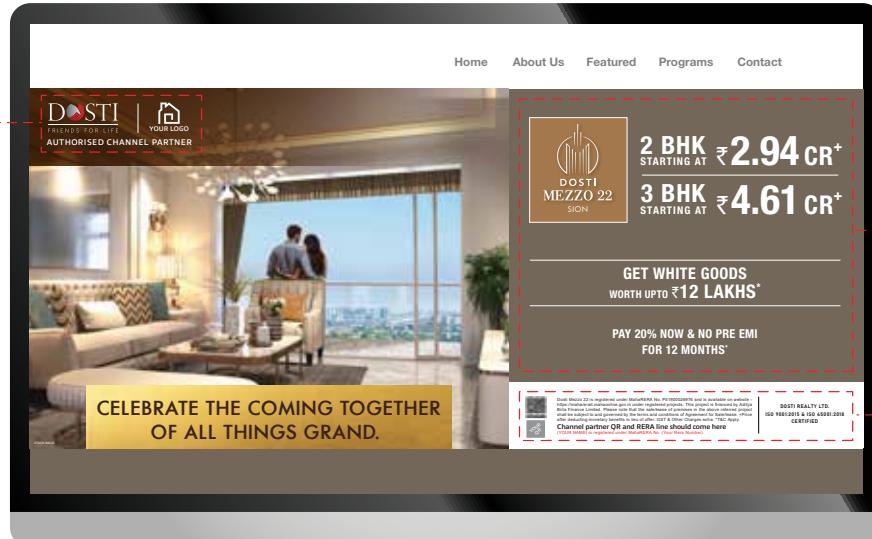


Creative Layouts

HORIZONTAL LAYOUT: (eg: website , banners, ads, etc)

Include Dosti Realty Ltd. logo and "Authorized Sales Partner" logo.

Display approved project details as included in the **brand kit**



Display the project's RERA number & approved details prominently.



VERTICAL LAYOUT: EG: WEBSITE, BANNERS, ADS, STANDEES ETC

Include Dosti Realty Ltd. logo & "Authorized Sales Partner" logo.

Display approved project details as included in the **brand kit**

Display the project's RERA number & approved details prominently.



Copy & Legal

- ▶ **RERA Numbers:** Always mention both your MAHARERA number and the project's MAHARERA number along with a QR code in all marketing materials.
- ▶ **Impersonation:** Clearly state that you are an authorized channel partner, not the company itself.

E-Mail & SMS Campaign

- ▶ **Provided Material:** Use only the EDM's, SMS texts and WhatsApp ads provided by the company. For custom materials, get written approval from the CP sales head.
- ▶ **Co-ordination:** Your relationship manager will co-ordinate the creation and approval of marketing materials.

Google Listing



- ▶ **No Listings:** Do not create your own Google listing or Google Map location pins for any Dosti Realty Ltd projects. Creating duplicate location pins for our projects/properties will be considered for strict action.

Use of QR Code

- ▶ **Inclusion:** All disclaimers and creatives must include valid QR codes provided by Dosti Realty Ltd.
- ▶ **Visibility:** Ensure QR codes are visible in all marketing materials, including websites and print materials.

Certification, Registration and Authorization

- ▶ **RERA Certification:** Ensure that you or your company holds a valid RERA Competency Certificate and MahaRERA Certificate.
- ▶ **Dosti Blue Circle App:** Register your details with Dosti Realty Ltd. on the Dosti Blue Circle App.
- ▶ **Marketing Authorization:** Obtain specific marketing authorization from Dosti Realty Ltd. to promote Dosti Realty Ltd. and its projects. This authorization is necessary for official representation and promotion of our projects.
